 - Must be studying full time with a current student ID card, or be a full-time apprentice or trainee with a current letter of employment
 - Be an Australian resident aged 13 years or older
- 3. Individuals may apply for up to \$1,000 in scholarship funding to be used towards costs incurred through study or training for a qualification associated with their career development. The maximum scholarship funding available is AUD \$20,000 (20 scholarships x \$1,000 per scholarship).
- 4. Scholarship recipients will be notified by telephone and names published on www.bcu.com.au/scholarships on Thursday, December 17, 2015.
- 5. By submitting your nomination form, you agree/understand:
 - Only complete nominations submitted prior to the closing date will be accepted.
 - Nominations can only be submitted via the online form at www.bcu.com.au/scholarships
 - The 2016 bcu Scholarships recipients will be determined by a bcu panel and bcu's decision is final.
 - To attend an interview with judges if required by bcu, and if successful, agree to attend the Scholarships presentation.
