

## **TERMS AND CONDITIONS OF COMPETITION**

BCU Bank 'Strangest Savings' competition.

- 1. This **Competition** is the BCU Bank "Strangest Savings" competition.

- 3. The **Competition Period** starts at 12.00 pm (AEST), 4 April 2024 and ends at 11.59 pm (AEST), 18 April 2024.
- 4. To be an **Eligible Entrant** in the Competition you must:
  - a. be 18 years or older and living in Australia;
  - b. during the Competition Period comment your response to the question "What's the strangest thing you've done to make extra cash?" on the competition post on BCU Bank's Instagram account;
  - c. be following the BCU Bank on Instagram account; and
  - d. provide BCU Bank with any information requested in connection with the Competition.
- 5. BCU Bank charges no fee for entering the Competition, but internet connection charges payable to your service provider may apply.
